Respondents

The case of the Complainant is as follows:

1. Tmt. Adhilakshmi , W/o A. Mani, has filed a complaint before this Forum on 28/05/2020. She has alleged that she has applied for name transfer for the electricity services which is at present in the name of her husband, who had expired in 2010. She had enclosed a copy of land documents issued by Government of

Puducherry standing in the name of the Complainant and her husband, her husband's death certificate and also a copy of the receipt issued by the Department in May 2019 for the amount collected for name transfer. She has requested for Orders for early name transfer. Hence, the complaint.

2. The complaint has been registered as C.C. No.27/2020 and notices have been sent to the Respondents 28/05/2020 to reply on or before 08/06/2020. The reply from the Assistant Engineer, Lawspet was received on 08/06/2020.

3. The Respondents in their reply have informed that necessary name transfer order has been issued on 04/06/2020 and enclosed a copy of the name transfer Order. The Assistant Engineer further informed that the name transfer order in 2019 was not issued, since the Complainant has not given the copy of the receipt for the payment made in May 2019 in Assistant Engineer's Office.

4. Since the name transfer order is issued, the Complainant vide her letter dated 11/06/2020 had withdrawn the Complaint.

ORDER

Since the Complainant had withdrawn the Complaint, consequent to the issue of name transfer order by the Electricity Department, the Complaint is closed.
