Respondents

The case of the complainant is as follows.

A Complaint was received from R. Gopal, Proprietor, M/s Mothercool Plastics and Injection Moulders, Puducherry on 03/03/2023. In the complaint, the Complainant had stated that he is having a industrial service connection bearing Policy Code 32-81-05-0410C which had been sub-leased for rental purpose. He has given a complaint to the Assistant Engineer, Boomianpet to disconnect the service for default in payment of current consumption charges for more than 4 months. However no action was taken by the Department. The Junior Engineer, Villianur disconnected the service only on 24/02/2023. Hence the complaint.

2. The complaint has been registered as C.C. No.53/2023 and copy of the complaint was sent to the Executive Engineer –Rural (North) and others for giving reply by 16.03.2023.

3. In the mean time, the Complainant through his letter dated 07/03/2023 informed his decision to this Forum to withdraw his complaint due to unforeseen reasons.

ORDER

In view of the submission made by the Complainant above, the complaint is closed as withdrawn.
