This case in C.C. No.67/2022 came up before this Forum for final hearing on 30/05/2022. After having stood over till this date for consideration this Forum has delivered the following:

The case of the Complainant is as follows:

1. A Complaint was received from V. Sujith, during the public interaction programme of this Forum held at Mahe on 29/04/2022. In the complaint, the Complainant had requested to replace electric lines near Government Girls High School Mahe and Old Age Home and on the way to Sree Kurumba Bhagavathi Temple which was in a damaged condition and may snap at any time. Hence, the Complaint.
2. The complaint was registered as C.C. No.67/2022 on 29/04/2022 and copy of the Complaint handed over to the Assistant Engineer, Mahe and others to furnish reply by 10/05/2022. Reply from the Assistant Engineer, Mahe / Respondent No.2 was received on 11/05/2022 and a copy of the same was communicated to the Complainant. The case was posted for hearing on 30/05/2022.
3. In the Affidavit dated 06/05/2022, the Assistant Engineer-Mahe / Respondent No.2 on behalf of Respondent 1 and 3 had stated that, the damaged electric line mentioned in the complaint were already rectified on 05/05/2022.
4. Hearing was held on 30/05/2022 at Puducherry through video conferencing. The Complainant called absent. During the hearing the Assistant Engineer, Mahe reiterated that the work has been completed.

- i. Since the issues raised by the Complainant has been attended, the complaint is treated as closed.
