ORDER:

The approval of Hon'ble Lieutenant Governor was accorded for the engagement of 20 nos. of Consultant Engineers in the Electricity Department vide reference 1st cited. Subsequently, the engagement of 12 nos. and 9# nos. of retired Assistant Executive Engineers/ Assistant/Junior/Foreman to work as Consultants on Contract basis in the Electricity Department for a period of 6 (six) months from 01-01-2024 to 30-06-2024 has been extended vide reference 3rd cited. As the necessity for their engagement continues in Sub-Stations, the Superintending Engineer-I, Electricity Department has sent a proposal for approval of the same. However, in the meantime 3 consultants were disengaged as they have attained age of 65 years and one consultant is unwilling to continue.

2. Hence, at present only 17 retired Engineers are serving and their services have to be extended for a further period of 6(six) months i.e. from 01-07-2024 to 31-12-2024. The period of contract of retired Consultant Engineers except Thiru G. Vazhumuni, JE [Sl.No.5] and Thiru M. Rajendiran, AEE [Sl.No.7] whose period of contract ends with effect from 25/07/2024 and 04/10/2024 respectively since they attained the age of 65 years as on that date or on which the private party takes over the DISCOM as a result of privatisation or till the necessity ceases thereof whichever is earlier, from the date of extension of their contract, as detailed below:-

3. The extension of engagement of retired Engineers as Consultants on contractual basis in the Electricity Department, Puducherry is subject to the following terms and conditions:

Terms and Conditions :

- i. *The engagement of Consultants will be on Full time basis and they shall not be permitted to take up any other assignment during the period of Consultancy. The Remuneration of the Consultants shall be calculated in accordance to the I.D. Note/Memorandum dated 01.12.2022 of the Finance Department, Puducherry.*
- ii. *The Consultants will be eligible for 12 days leave in a calendar year on pro-rata basis.*
- iii. *The Consultants will initially be engaged for a period of six months, subject to extension, if the necessity arises, with the approval of the Competent Authority, or curtailed, if the necessity there for ceases or till the date of taking over of the DISCOM on account of privatization whichever is earlier.*
- iv. *The engagement on contract basis will be subject to execution of an agreement with the Consultant so engaged as per the I.D. Note / Memorandum dated 11.09.2014 of the Finance Department.*

3. This issues with the concurrence of the Finance Department, Puducherry vide their I.D. No.e-11489/FD/F3/FC/2024-25 dated 20/08/2024.
