## NOTIFICATION

Sub: ED – Estt. – Engagement of **10** retired Foreman/Junior Engineers / Assistant Engineers as Consultant Engineers in the Electricity Department, Puducherry – Reg.

Applications are invited from Officials of the Electricity Department, Puducherry who had retired from the post of Foreman/Junior Engineers / Assistant Engineers within five years, for engagement as Consultant Engineers on remuneration basis to perform shift duties at various Sub-Stations / O&M sections in the Electricity Department, Puducherry.

2. The engagement of Consultant Engineers will be subject to the following Terms & Conditions. –

#### I. ELIGIBILITY:

The Candidate must be within the age of 64 years as on 30.11.2023

He / She should have retired from the post of Foreman/Junior Engineers / Assistant Engineers in the Electricity Department, Puducherry with a minimum of 10 years of services as JE / AE as the case may be (both service includes).

He/She should have retired from the post of Foreman with a minimum of 5 years of experience in Sub-Station for consideration.

He / She should possess adequate knowledge and experience on working in sub stations operated by the Electricity Department, Puducherry.

He / She should be well versed with the operation of equipment related to the functioning of 230 KV, 132 KV and 110 KV substations and O&M section duties at crucial points in the Electricity Department, Puducherry.

#### II. PERIOD OF ENGAGEMENT:

The initial period of engagement will be six months, subject to extension if necessity arises, with the approval of the Competent Authority.

The engagement is of full-time nature and hence the persons engaged as Consultant Engineers must not take any other employment / assignment elsewhere during the period of engagement.

The engagement of Consultant Engineers is of temporary (non-official) nature against the specific jobs and the engagement may be cancelled at any time by the Department without assigning any reason. As such, the Consultant Engineers cannot claim to be engaged for the full period of their contracted engagement.

#### III. PLACE OF WORKING:

The Consultant Engineers will be employed at any of the Sub Stations under the jurisdiction of the Electricity Department, Puducherry to perform shift duties / maintenance of substations.

If need arises, the services of Consultant Engineers may be placed at some other substations different from the one at which they are initially engaged. The duties shall include night shifts.

## IV. CONSULTANCY FEE:

The Consultant Engineers will be entitled for a monthly Consultancy Fee as followed as per order issued by the Finance Department, Puducherry vide I.D. Note / Memorandum No.46324/FE/F3/2014, dated 11/09/2014 and dated 01/12/2022 of the Under Secretary to Govt. (Finance), Puducherry.[Last Pay Drawn - Pension]

#### V. LEAVE:

The Consultant Engineers are eligible for 12 days leave in a calendar year on a pro-rata basis.

Therefore, the Consultant Engineers will not be paid any remuneration in case of his absence period beyond 12 days in a calendar year (calculated on pro-rata basis)

The Electricity Department would be free to terminate their services in case of absence by more than 15 days beyond the entitled leave in a calendar year.

#### VI. AGREEMENT:

Agreement shall be executed with the Consultant Engineers during the time of engagement.

#### VII. ALLOWANCES:

The Consultant Engineers are not entitled to any allowances such as Dearness Allowance, Residential Telephone, Transport Allowance / Facility, Residential Accommodation, Personal staff, Medical Reimbursement and Insurance etc. However, TA & DA as per the rules will be paid in case of any official duty outside the Headquarter as per the entitlement on the date of their retirement.

Their engagement as consultant shall not be considered as a case of re-employment.

#### VIII. SELECTION PROCEDURE:

The applications received in response to the Notification will be scrutinized by this Department in the light of consultancy guidelines and thereafter submit a proposal before the "Consultancy Evaluation Committee", which comprises of Secretary to Govt. (Power) as Chairman, Under Secretary to Govt. (Power) and Superintending Engineer-cum-Head of Department as Members. The applications will be scrutinized by this Department on the basis of past experience, relevant educational qualification and standing of the applicant in his field of work.

After approval of the Consultancy Evaluation Committee, the Industrial Development (Power) Department will obtain concurrence of the Finance Department and thereafter submit the proposal for approval of the Competent Authority viz., the Hon'ble Lieutenant Governor before engagement as Consultant Engineers.

Other items of engagement of Consultant Engineers will remain same as per the rules and orders as applicable to this Department from time to time.

#### OTHER CONDITIONS:

- 1. The period of engagement of Consultant Engineers will be initially for a period of 6 months and further extension of contract will be considered subject to requirement of services.
- 2. The persons engaged on contract basis have no right to claim for permanent or regular employment in this Administration as this is purely a temporary contractual engagement for a specific tenure period and will remain valid up to which the engagement is approved on each occasion.
- 3. The persons engaged on contract basis will have to work at any region in the U.T. of Puducherry and may have to work in shifts / night shifts.
- 4. The persons engaged on contract basis are expected to conform to the rules of conduct and discipline as applicable to the other employees of the Department.
- 5. The persons engaged on contract basis should not have been convicted by any Court of Law and shall not have any adverse character or antecedents.
- 6. In case any information given or declaration by the candidate is found to be false or if the candidate has wilfully suppressed any material information relevant to his appointment, he / she will be liable to be removed from the contractual engagement and any action taken as deemed fit by the Secretary (Power).
- 7. Applications incomplete in any aspect will be summarily rejected.
- 8. The Competent Authority reserves the right to make any changes in the recruitment process with regard to number of vacancies, age, qualification, experience and other conditions of eligibility / selection process etc.
- 9. The Competent Authority also reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
- 10. The claims of the candidates with regard to the date of birth, educational / technical qualifications and community are accepted only on the information furnished by them in their application without physical verification of their claims. Their candidature therefore will be provisional at all stages and this Department reserves the right to reject any candidature at any stage, even after the selection has been made.
- 11. Candidates from other States / Union Territories are not eligible to apply for the post and only those retired from the Electricity Department are eligible to apply.

- 12. Change of address, if any, after submission of application should be intimated to the Department or otherwise the Department is not responsible for any postal delay / non delivery of letters etc.
- 13. The Competent Authority reserves the right to post / transfer the selected candidates anywhere in the Electricity Department, Union Territory of Puducherry.
- 14. If, the Consultant Engineers is unable to address the assigned work or if the quality of the assigned work is not to the satisfaction of the Department or if, the Consultant Engineer fails in timely achievement of the milestones as decided by the Department; or if the Consultant Engineer is found lacking in honesty and integrity, the Electricity Department reserves the right to terminate the contract, by giving fifteen days' notice to the Consultant Engineer.
- 15. The engagement of retired Foreman/Junior / Assistant Engineer as Consultant is till the date of taking over the DISCOM by the private party as a result of privatization or till the necessity there for is essential, whichever is earlier.
