2. The extension of engagement of retired Engineers as Consultants on contractual basis in this Department is subject to the following terms and conditions.

Terms and Conditions:

- i. The engagement of Consultant will be on Full time basis and they shall not be permitted to take up any other assignment during the period of Consultancy. The Remuneration of the Consultants shall be calculated in accordance with the I.D.Note/Memorandum dated 01.12.2022 of the Finance Department, Puducherry.
  - ii. The Consultant will be eligible for 12 days leave in a calendar year on pro-rata basis.
  - iii. The Consultants will initially be engaged for a period of six months, subject to extension, if the necessity arises, with the approval of the Competent Authority, or curtailed if the necessity ceases or till the date of taking over of the DISCOM on account of privatization whichever is earlier.
  - iv. The engagement on contract basis will be subject to execution of an agreement with the Consultant so engaged as per the I.D.Note / Memorandum dated 11.09.2014 of the Finance Department.
3. This issues with the concurrence of the Finance Department, Puducherry vide I.D.Note No.734/FD/F3/FC/2023-24, dated 25.09.2023.
