ORDER

Sub: ED – Estt. – Grant of first, second and third Financial Up-gradation under Modified Assured Career Progression Scheme to Thiru. R.Anbazhagan, Assistant Engineer of this Department – Orders – Issued.

2. O.M. No.35034/3/2015-Estt.(D), dt. 22.10.2019 of DoPT, New Delhi, communicated vide I.D. Note/O.M. No.A.32019/1/2009/DPAR/ CCD(2) dated 09.11.2019 of the Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry.
3. I.D.No.97483/1/ID(P)D/P7/MACP/AE/2023/25, dt.11.01.2024 of the Industrial Development (Power) Department, Puducherry.

Pursuant to the Government Orders/Office Memorandum cited above, the approval of the Departmental Screening Committee is conveyed for grant of first, second and third financial up-gradation under Modified Assured Career Progression Scheme to the official mentioned in the Annexure vide references 3rd cited and the details of eligibility of Pay Level on grant of financial up-gradation in the 7th CPC Pay Matrix is also detailed in the **Annexure**.

2. The official is entitled to exercise option to get his pay fixed in the higher pay structure based on the date of increment in the present pay structure, as per the rules in force from time to time.
3. There will not be further fixation on functional promotion to the next higher post following the financial up-gradation, if it is in the same pay level as granted under MACPs. But if it happens to be in a post carrying higher pay level than what is available under MACPs, then they shall be placed in the level to which they are promoted at a cell in the promoted level equal to the figure being drawn by them on account of MACP. If no such cell is available in the level to which promoted, they shall be placed at the next higher cell in the level. The employee may have an option to get their fixation done either on the date of promotion or w.e.f. the date of next increment as per the option to be exercised by them.
4. The pay of the official will be fixed under the provision of F.R. 22 (I) (a) (1).
5. The grant of financial up-gradation under the MACP Scheme is subject to the fulfillment of the conditions stipulated in the G.O./I.D.Note/O.Ms under reference 1st & 2nd cited.
6. The MACP Scheme benefits are subject to Audit and excess/ erroneous payments, if any, will be recovered in future.
7. The release of ACP/MACP arrears to the Government employees shall be claimed in terms of I.D.Note/O.M.No.529/FD/F3/2021 dated 08.10.2021 of the Financial Department, Puducherry.
- 8. The financial up-gradation under MACP Scheme are subject to condition that as Thiru. R.Anbazhagan, Assistant Engineer was granted pay fixation on promotion from the post of Tester to Draughtsman (1230 to 1290) and from the post of Draughtsman to Junior Engineer (Rs.1380 to Rs.1440), the pay fixation granted to the above official from the post of Tester to Draughtsman and from the post of Draughtsman to Junior Engineer and the fixation benefits gained up to December 1995 shall be nullified and consequent increments granted thereafter also be revised and subsequent re-fixation shall be recovered in the MACP arrears due to him.**
