ORDER

Sub: ED - Estt. - Grant of first, second and third Financial Upgradation under Modified Assured Career Progression Scheme to Thiru. N.Arumugam, Junior Engineer (Retired) of this Department - Orders - Issued.

- Ref: 1. O.M. No.35034/3, 2008-Estt.(D), dt. 19.05.2009 of DoPT, New Delhi, communicated vide G.O.Ms.No.84, dated 26.08.2009 of the Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry.
2. O.M. No.35034/3, 2015-Estt.(D), dt. 22.10.2019 of DoPT, New Delhi, communicated vide I.D. Note/O.M. No.A.32019/1/2009/DPAR/CCD(2) dated 09.11.2019 of the Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry.
3. I.D.No.377/ID(PD)/P7/MACP/JE/2023/2000, dt.13.09.2023 of the Industrial Development (Power) Department, Puducherry.

Pursuant to the Government Orders/Office Memorandum cited above, the approval of the Departmental Screening Committee is conveyed for grant of first, second and third financial upgradation under Modified Assured Career Progression Scheme to the official mentioned in the Annexure vide references 3rd cited and the details of eligibility of Pay Level on grant of financial upgradation in the 7th CPC Pay Matrix is also detailed in the **Annexure**.

2. The official is entitled to exercise option to get his pay fixed in the higher pay structure based on the date of increment in the present pay structure, as per the rules in force from time to time.
3. There will not be further fixation on functional promotion to the next higher post following the financial upgradation, if it is in the same pay level as granted under MACPs. But if it happens to be in a post carrying higher pay level than what is available under MACPs, then he shall be placed in the level to which he is promoted at a cell in the promoted level equal to the figure being drawn by him on account of MACP. If no such cell is available in the level to which promoted, he shall be placed at the next higher cell in the level. The employee may has an option to get his fixation done either on the date of promotion or w.e.f. the date of next increment as per the option to be exercised by him.
4. The pay of the official will be fixed under the provision of F.R. 22 (I) (a) (1).
5. The grant of financial upgradation under the MACP Scheme is subject to the fulfillment of the conditions stipulated in the G.O./I.D.Note/O.Ms under reference 1st & 2nd cited.
6. The MACP Scheme benefits are subject to Audit and excess/ erroneous payments, if any, will be recovered in future.
7. The release of ACP/MACP arrears to the Government employees shall be claimed in terms of I.D.Note/O.M.No.529/FD/F3/2021 dated 08.10.2021 of the Financial Department, Puducherry.
8. The financial upgradation under MACP Scheme are subject to condition that as Thiru. N.Arumugam, Junior Engineer (retired) was granted pay fixation with notional increments consequent on his promotion from the post of Tester to Draughtsman (Rs.354 to 370 on 31.07.1985) and then switched over to 4th CPC and got his pay fixed at Rs.1260 w.e.f., 01.01.1986 and thereafter, on promotion from the post of Draughtsman to Junior Engineer he got his pay was fixed again at Rs.1400 i.e., minimum of the pay scale w.e.f. 29.07.1987 the same was later switched over of 5th CPC pay scale w.e.f., 01.01.1996 and got his pay fixed at Rs.5500 the minimum of the pay scale Rs.5500-175-9000, the pay fixation with notional increments and consequent increments granted to the official on promotion from the post of Tester to Draughtsman and from the post of Draughtsman to Junior Engineer Gr.II shall be revised as per FR 22 I a 2 so that the fixation benefits gained until December 1995 shall be nullified and subsequent re-fixations shall also be effected and the difference of pay shall be recovered in the MACP arrears due to him.
