Pursuant to the G.O. first cited communicating the Modified Assured Career Progression Scheme notified by the Government of India, approval of the Departmental Screening Committee is conveyed for the grant of **FIRST** financial up-gradation under Modified Assured Career Progression Scheme to the Helpers mentioned in the "Annexure" to this Order, to the level -3 of Pay Matrix (PB Rs.5200-20200 - 2000 (Grade Pay) with effect from the date noted against each.

- The officials are entitled to exercise option to get their pay fixed in the higher pay structure based on the date of increment in the present pay structure as per the rules in force from time to time.
- There will be no further fixation on functional promotion to the next higher post following the financial up-gradation, if it is in the same grade pay. But if it happens to be in a post carrying higher grade pay, no fixation would be available and only difference of grade pay would be made available.
- If a regular promotion is offered, but was refused by the staff before becoming entitled to a financial up-gradation, no financial up-gradation shall be allowed. If however, financial up-gradation has been allowed due to stagnation and the staff subsequently refuses promotion, it shall not be a ground to withdraw the financial up-gradation. They shall, however, not be eligible to be considered for further financial up-gradation till they agree to be considered for promotion again and the next financial up-gradation shall also be deferred to the extent of period of debarment due to the refusal.
- The pay of the officials will be fixed under the provision of F.R. 22 (1)(a)(1).
- The grant of financial up-gradation under the M.A.C.P. Scheme is subject to the fulfillment of the conditions stipulated in G.O.Ms.84 dated 26.08.2009.
- The MACP Scheme benefits are subject to audit and excess/erroneous payment, if any will be recovered in future. This order is also subject to the conditions stipulated in para.5 of G.O.M.S No.6 dated 02.02.2019 of the Under Secretary to Govt. (Power), Puducherry.
- The release of ACP/MACP arrears to the Government employees shall be claimed in terms of I.D. Note/O.M. No.529/FD/F3/2021 dt. 08.10.2021 of the Finance Department, Puducherry.
