ORDER

Sub: ED - Estt. - Grant of second financial upgradation under Assured Career Progression Scheme to Thiru Mattaparthi Subba Rao, Assistant Line Inspector (Retired) of this Department - Orders - Issued.

- Ref: 1. O.M. No.35034/1/97-Estt(D), dt. 09.08.1999 of the Ministry of Personnel, Public Grievances and Pensions (DoPT), Govt.of India.
2. I.D.No.316/CS(P)/P7/ACP/2021, dt.23.03.2022 of the Industrial Development (Power) Department, Puducherry.

Pursuant to the Office Memorandum cited above, the approval of the Departmental Screening Committee is conveyed for grant of second financial upgradation under Assured Career Progression (ACP) Scheme to the official mentioned in the Annexure vide reference 2nd cited and the details of eligibility of Grade Pay on grant of financial upgradation is also detailed in the **Annexure**.

2. The official is entitled to exercise option to get his pay fixed in the next higher scale based on the date of increment in the present scale of pay, as per the rules in force from time to time.
3. There will not be any further fixation on functional promotion to the next higher post following the financial upgradation. As such, there shall be no additional financial upgradation for the senior employee on the ground that the junior employee in the grade has got higher pay scale under the ACP scheme.
4. In case of refusal to accept higher post on regular promotion subsequently, the employee should be reverted from the higher scale granted under Assured Career Progression Scheme. However as and when he accepts regular promotion thereafter, he shall become eligible for the second upgradation under the ACP scheme only after he completes the required eligibility service period under the ACP scheme in that higher grade subject to the condition that the period for which debarred for regular promotion shall not count for the purpose.
5. The pay of the official will be fixed under the provision of F.R. 22 (I) (a) (1) subject to a minimum financial benefit of Rs.100/-.
6. The grant of financial upgradation under the ACP Scheme is subject to the fulfillment of the conditions stipulated in the O.M under reference 1st & 2nd cited.
7. The ACP Scheme benefits are subject to Audit and excess/ erroneous payments, if any, will be recovered in future.
8. The release of ACP/MACP arrears to the Government Employee shall be claimed in terms of I.D.Note/O.M.No.529/FD/F3/2021, dt.08.10.2021 of the Finance Department, Puducherry.

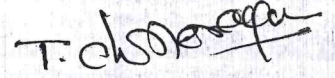
