Sub: ED - Estt. - Grant of first and second Financial Upgradation under Modified Assured Career Progression Scheme to Tmt. S.Vijayakumari, Junior Engineer of this Department - Orders - Issued.

Pursuant to the Government Orders/Office Memorandum cited above, the approval of the Departmental Screening Committee is conveyed for grant of first and second financial upgradation under Modified Assured Career Progression Scheme to the official mentioned in the Annexure vide references 3rd cited and the details of eligibility of Pay Level on grant of financial upgradation in the 7th CPC Pay Matrix is also detailed in the **Annexure**.

2. The official is entitled to exercise option to get her pay fixed in the higher pay structure based on the date of increment in the present pay structure, as per the rules in force from time to time.
3. There will not be further fixation on functional promotion to the next higher post following the financial upgradation, if it is in the same pay level as granted under MACPs. But if it happens to be in a post carrying higher pay level than what is available under MACPs, then she shall be placed in the level to which she is promoted at a cell in the promoted level equal to the figure being drawn by her on account of MACP. If no such cell is available in the level to which promoted, she shall be placed at the next higher cell in the level. The employee may has an option to get her fixation done either on the date of promotion or w.e.f. the date of next increment as per the option to be exercised by her.
4. The pay of the official will be fixed under the provision of F.R. 22 (I) (a) (1).
5. The grant of financial upgradation under the MACP Scheme is subject to the fulfillment of the conditions stipulated in the G.O./I.D.Note/O.Ms under reference 1st & 2nd cited.
6. The MACP Scheme benefits are subject to Audit and excess/ erroneous payments, if any, will be recovered in future.
7. The release of ACP/MACP arrears to the Government employees shall be claimed in terms of I.D.Note/O.M.No.529/FD/F3/2021 dated 08.10.2021 of the Financial Department, Puducherry.
8. **The financial upgradation under MACP Scheme are subject to condition that as Tmt.S.Vijayakumari, Junior Engineer was granted pay fixation with notional increments consequent on her promotion from the post of Tester to Draughtsman (Rs.5300 to 5450 on 31.12.1997 (including notional increment)). Thereafter, on promotion from the post of Draughtsman to Junior Engineer she got her pay re-fixed again at Rs.6950 from Rs.6500 (including notional increment) w.e.f., 01.12.2004 in pay scale Rs.5000-150-8000. Later, the pay in the post of Junior Engineer was once again re-fixed at Rs.6375 on 20.09.2004 and at Rs.6550 w.e.f.01.12.2004 (including notional increment), the pay fixation with notional increments and consequent increments granted to the above official on promotion from the post of Tester to Draughtsman and from the post of Draughtsman to Junior Engineer Gr-II shall be revised as per FR 22 I a 2 so that the fixation benefits gained from the post of Tester to Draughtsman shall be nullified and subsequent re-fixations shall also be revised and the difference of pay shall be recovered in the MACP arrears due to her.**
