3. Her joining Report dated 16-03-2018.

In pursuance of the Memorandum first cited, on relief from the post of Storekeeper Gr-III, PHC, Kirumampakkam, O/o the Deputy Director (FW&MCH), Puducherry under Technical resignation vide reference second cited and on having reported for duty in this division on the forenoon of 16-03-2018, Tmt. D. Sathiyavani, is appointed as UDC Group (C) on temporary basis against the existing vacancy.

2. Her pay is fixed at Rs.25500/- per month (Cell-1 of Level-4) in the Pay Matrix plus usual allowances as admissible under rules in force from time to time.

3. She is placed on probation in the grade of UDC for a period of two years with effect from the forenoon of 16/03/2018.

4. She should also work as cashier if she is so directed by the Head of Department/Office, for which she should furnish necessary Fidelity Bond/Cash Security.

5. She should pass the prescribed Departmental Tests viz. Accounts Test for Sub-ordinate Officers(Part I and II) and Common General Departmental Test for Ministerial Staff and should also pass typewriting test (Lower Grade) in English or Tamil or Malayalam or Telugu conducted by a recognized Board of Technical Education in case she has not passed the said test conducted by the recognized Board of Technical Education earlier and Office Automation during the period of probation, failing which she will be ousted from service.

6. In case, it is found that she was guilty of misconduct involving moral turpitude, which would disqualify her for Government service, or had suppressed any material fact relating to her conduct prior to entry into Government Service or if any declaration given or information furnished by the candidate proves to be false, she will be liable to be discharged from service and such other action as Government may deem necessary.

7. The appointment is temporary and may be terminated at any time by a month's notice given by either side without assigning any reason. The Appointing Authority, however reserves the right of terminating the service of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.

8. As no person professing a religion different from the Hindu or Sikh religion can be deemed to be a member of Scheduled Caste, the candidate should inform about the change, if any, of her religion to her Appointing/administrative authority immediately after such a change.

9. The appointment is provisional and is subject to the Caste/Community Certificate being verified through the proper channels in respect of the candidates selected under OBC/MBC/BT/BCM/EBC/SC reservation, and if the verification reveals that the claim to belong to OBC/MBC/BT/BCM/EBC/SC is false, her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.

10. Other conditions of service will be governed by the relevant rules and orders in force from time to time.
