In pursuance of the Memorandum cited above, and on having reported for duty **Thiru. Selvam, S/o. Selvaraj**, is appointed as **“Construction Helper” (Work Charged)** on temporary and regular basis with effect from the afternoon of 02.05.2017 in the Marapalam West O&M, Office of the Executive Engineer, Urban O&M, Electricity Department, Puducherry against the existing vacancy.

2. He will draw the pay of **Rs.19900/-** in the **Cell 1 of Level 2** plus usual allowances as admissible under the rules in force from time to time.

3. The appointment is temporary and regular basis and may be terminated at any time by a month's notice given by either side without assigning any reasons. The Appointing Authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.

4. The offer of appointment is subject to the outcome of the O.A. No. 970/2015 filed by Thiru. A. Sinuvasan, O.A. No. 310/00973/2015 filed by Thiru. M. Periyavelu and others, O.A. No. 310/00974/2015 filed by Thiru. L. Jagan and 2 others, O.A. No. 310/01023/2015 filed by Thiru. B. Gunalan, O.A. No. 310/00767/2015 filed by Thiru. K. Kumaraguru, O.A.No. 310/01115/2015 filed by Thiru. Rajakumar, O.A.No. 310/0936/2015 filed by Smt. Muniammal, O.A. 310/0937/2015 filed by Smt. Mahalakshmi and O.A. No. 310/01447/2015 filed by Thiru C. Venguedeswaran before the Hon'ble Central Administrative Tribunal, Madras Bench.

5. In case it is found that he was guilty of misconduct involving moral turpitude which would disqualify him for Government Service, or has suppressed any material fact relating to his conduct prior to entry into Government Service or if any declaration given or information furnished by the candidate proves to be false, he will be liable to be discharged from service and such other action as the Government may deemed fit necessary.

6. As no person professing a religion different from the Hindu or Sikh religion can be deemed to be member of Scheduled Caste, the candidate should inform about the changes, if any, of his religion to his appointing / administrative authority immediately after such a change (This applies only in the case of Scheduled Caste candidates).

7. He is placed on probation for two years in the post of Construction Helper (Work Charged) with effect from the afternoon of 02.05.2017.

8. Other terms and conditions mentioned in the Memorandum first cited shall remain unchanged.

9.. Certified that:

i) He has produced certificate of fitness from the Resident Medical Officer, Government General Hospital, Puducherry.

ii) He has submitted declaration in the prescribed forms relating to his marital status.

iii) He has submitted attestation forms for verification of character and antecedents.
