Sub: ED - Estt./ - Grand of Third Financial Up-gradation under MACP Scheme to Junior Engineer, Electricity Department, Puducherry - Orders - issued.

Pursuant to the G.O. first cited communicating the Modified Assured Career Progression Scheme notified by the Government of India, approval of the Departmental Screening Committee is conveyed for the grant of third financial up-gradation under Modified Assured Career Progression Scheme to Junior Engineers, to the next higher Grade Pay in the Pay Band - 2 Rs.9300-34800 + GP Rs.4600 in PB-2 with effect from dates mentioned against each Junior Engineer in the table appended below;

2. The Officials are entitled to exercise the option to get their pay fixed in the higher pay structure based on the date of increment in the present pay structure as per rules in force from time to time.

3. There will not be further fixation and functional promotion to the next higher post following the financial up-gradation if it is in the same grade pay. But if it happens to be in the post carrying higher grade pay, no fixation would be available and only the difference of grade pay would be made available.

4. If a regular promotion is offered but was refused by the staff before becoming entitled to a financial up-gradation, no financial up-gradation shall be allowed. If however, financial up-gradation has been allowed due to stagnation to the staff subsequently refuses promotion, it shall not be a ground to withdraw the financial up-gradation. He shall however, not be eligible to be considered for further financial up-gradation till he/she agrees to be considered for promotion again and the next financial up-gradation shall also be deferred to the extended period of debarment due to refusal.

5. The pay of the official will be fixed under the provision of FR 22 (i) (a) (1).

6. The grant of financial up-gradation under the MACP Scheme is subject to the fulfilment of the conditions stipulated in G.O.Ms.No.84, dated 26.08.2009 of the Department of Personal and Administrative Reforms (Personal Wing), Puducherry.

7. The MACP Scheme benefits are subject to audit and excess / erroneous payment, if any, will be recovered in future.
