ORDER

Sub: Electricity Department – Establishment - Grant of Financial Up-gradation under Modified Assured Career Progression Schemes to 6 Wiremen – Orders – Issued

Ref: 1 G.O. Ms. No.84, dated 26.08.2009 of the Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry.
2. OM. No. 18319 /ID(P)D/2019/P5 dated 17.01.2019 of the Industrial Development (Power) Department, Puducherry.

Pursuant to the G.O. first cited communicating the Modified Assured Career Progression Scheme notified by the Government of India, approval of the Departmental Screening Committee is conveyed for the grant of Second financial up-gradation under Modified Assured Career Progression Scheme to 6 WIREMEN mentioned in the “Annexure” to this order, to the Pay Matrix of level 5 with effect from the date noted against each.

2. The officials are entitled to exercise option to get their pay fixed in the higher pay structure based on the date of increment in the present pay structure, as per the rules in force from time to time.

3. There will not be further fixation on functional promotion to the next higher post following the financial up-gradation, if it is in the same grade pay. But if it happens to be in a post carrying higher grade pay, no fixation would be available and only difference of grade pay would be made available.

4. If a regular promotion is offered, but was refused by the staff before becoming entitled to a financial up-gradation, no financial up-gradation shall be allowed. If however, financial up-gradation has been allowed due to stagnation and the staff subsequently refuses promotion, it shall not be a ground to withdraw the financial up-gradation till he agrees to be considered for promotion again and the next financial up-gradation shall also be deferred to the extent of period of debarment due to the refusal.

5. The pay of the officials will be fixed under the provision of F.R.22 (1) (a) (1).

6. The grant of financial up-gradation under the MACP Scheme is subject to the fulfillment of the conditions stipulated in G.O.Ms.84, dated 26.08.2009.

7. This issues with the approval of the Commissioner -cum- Secretary to Government (Power).
