In pursuance of the Office Memorandum second cited and on promotion to the post of UDC on adhoc basis with notional effect from 28-12-2015 on par with his junior Thiru. G. Sidambaram, UDC and with monetary benefit from the date of his actual joining in promotional post of UDC and on having reported for duty Thiru. S. Ganesan, LDC is posted as UDC on adhoc basis in the O/o the EE-U(O&M), Electricity Department, Puducherry with effect from the forenoon of 08-01-2018 and he is deemed to have notionally promoted and posted as UDC with effect from 28-12-2015 vice Thiru. V. Soundarame, UDC retired.

2. He will draw the pay of Rs.10390+2400(G.P)= Rs.12,790/- in the payband of PB1-Rs.5200-20200+2400(GP) with date of next increment on 01-07-2016.

3 He is not entitled for further fixation in the promotional post of UDC as he had already been granted Second financial Upgradation under MACP Scheme in the pay band of PB1-Rs.5200-20200 plus Grade Pay of Rs.2000/- while serving in the post of LDC vide reference first cited. Now, therefore, only difference of Grade Pay is admissible in the promotional post of UDC.

4. He is entitled to draw monetary benefits only from the date of his actual joining in the post of UDC i.e. with effect from the forenoon of 08-01-2018 as detailed in the "Annexure"
