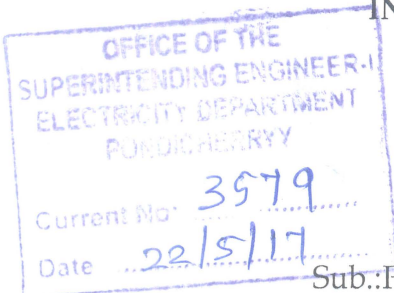

ORDER

Sub.: Power- Implementation of directions of Hon'ble CAT in O.A. No. 1101/2003 dt. 07.06.2005 and upheld by the Hon'ble High Court in M.P. Nos. 1/2006 and 1/2007 in W.P. No. 43860/2006 and Supreme Court in SLP(Civil) No. 5962 of 2010 filed by Thiru. R. Murali, presently officiating as Executive Engineer, Electricity Department, Puducherry - Orders - Issued.

WHEREAS, Thiru. R. Murali, Assistant Engineer, Electricity Department, Puducherry, had filed a case before the Hon'ble Central Administrative Tribunal, Chennai, in O.A. No. 1101/2003, praying for direction to the Respondents to promote him to the post of Assistant Executive Engineer under SC quota. The Hon'ble Central Administrative Tribunal, Chennai allowed the application and in their judgement dated 07.06.2005 directed to review the case of the Applicant for promotion to the post of Assistant Executive Engineer in Electricity Department, Puducherry, with effect from 12.08.2002 vis-à-vis the respondent Engineers, by conducting a review Departmental Promotion Committee.

AND WHEREAS, in compliance of the Orders of the Hon'ble Central Administrative Tribunal, Chennai and based on the recommendations of the review Departmental Promotion Committee Meeting held on 23.03.2017, the Hon'ble Lieutenant Governor, Puducherry, is pleased to order the notional promotion of Thiru. R. Murali, presently officiating as Executive Engineer, to the following grades with effect from the dates indicated against each:-
